## 1. Purpose

The provisions in this document will be used by the XCSO Para-Nordic Committee, hereafter called PNC, to identify Para-Nordic athletes who qualify for the Ontario Para-Nordic Ski Team (OPNST) 2018

### 1.1 Definitions

### 1.2 Eligibility

**To be eligible for selection to the Ontario Para-Nordic Ski Team athletes must meet each of the following criteria:**

- **hold a valid 2017-2018 CCC racing licence with on Ontario club**
- **be registered with a XCSO club at the time of the race**
- **be a Canadian citizen or have Permanent Resident status**
- **be a permanent resident of Ontario<sup>1</sup> prior to the beginning of the Ontario Cup race series**

Para-Nordic Canada Points List (PN CPL) points will **not** be awarded retroactively for a given race if an athlete who, on the day of a points race, did not meet one of the criteria listed above, subsequently meets all of them (e.g., obtains a license or club registration after the race). A day license is NOT a racing license and will not enable athletes to accumulate PN CPL points.

<sup>1</sup>A valid Ontario Health Card OR an Ontario Driver's License will be used as proof of permanent Ontario residency.

### 1.3 Selection Races – Date & Location

The races identified in this document will be used in the selection process for the teams and events named within. Races included in the selection process are identified as those where the depth of field of Para-Nordic athletes is 2 or more athletes per category per gender as CPL will be generated from these races. The identified races change from year to year. The selection races for the 2017/2018 season are

#### **ONPNST will be pre-approved for the Ontario Winter Games (OWG)**

There will be 8 athletes selected at Ontario Cup at Walden Nordic Ski Club (see race date and races below)

Each District: NCD; SOD; LSSD will have district camp and qualifier. Each district can name 4 Para-Nordic Athletes to attend OWGS

Cross Country Canada racing licence is required for the OWGs

#### **ON Para-Nordic on snow Training camp: Location Sudbury, ON Thursday, December 28 to Saturday, December 30**

#### **ON Para-Nordic on snow Training camp: SOD Location TBD Sunday, January 14, 2018**

#### **ON Para-Nordic on snow Training camp: LSSD Location TBD**

#### **ON Para-Nordic Training camp: NCD Location TBD**

#### **Force Majeure**

Ontario Winter Games Event. Injury, illness, family misfortune, exceptional circumstances and equipment breakage will be considered valid grounds for a force majeure appeal. Appeal documentation to be provided to Cross Country Ski Ontario must include but is not limited to:

- Physician letter if health related
- A letter/email outlining exceptional circumstances
- A letter/email from present personal/club coach indicating their intent to support their athlete as an OPNDST member.

Appeals will be evaluated by the PNC taking into consideration the reason for the appeal and results from other races. Force majeure documentation must be received no later than **5pm January 26, 2018**.

**2. 2018 Ontario Para-Nordic Ski Team****2.1 Team Description****2.1.1 Benefits**

It is the intent of the PNC that, where possible, athletes named to the Ontario Para-Nordic Ski Team receive the following:

1. Registration costs for individual races at the Canadian Para-Nordic National Championships,(OPNST 2018-2019)
2. Coaching support to Canadian Para-Nordic National Championships,
3. Access to personal coach support options for athletes who do not have a club coach,
4. Ontario Para-Nordic Ski Team clothing (please note only OPNST athletes will receive race suits),
5. Eligibility for Ontario Carding when such support is available.

Ontario Para-Nordic Ski Team (OPNST) members may be provided XCSO support to attend special training camps or elite racing events, as specified by

the PNC, on a cost-sharing basis. OPNST athletes are eligible to receive the cost sharing only when the athlete travels with the OPNST and attends XCSO-organized camps and events as a member of the OPNST.

### **2.1.2 Obligations**

Ontario athletes who accept their nomination to the Ontario Para-Nordic Ski Team (OPNST) will be asked to sign an Athlete Contract, pay a team fee, as specified by the PNC, and fill out and sign the Athlete's Code of Conduct. In addition, athletes are expected to attend a minimum of one Ontario Dryland Camp (not including designated OPNST) through the year. OPNST athlete's attendance at one or more of these camps is intended to provide program continuity by creating opportunities for Ontario's elite athletes to connect with and motivate developing athletes from across the province.

### **2.1.3 Team Fee**

Ontario Para-Nordic Ski Team nominees for 2018 will be asked to pay a team fee of \$375 to confirm their participation on the Team. The fee will be used to offset the cost of ONPST trips. This fee is due, along with the signed Athlete Contract within 30 days of the posting of the Ontario Para-Nordic Ski Team nomination list on the XCSO website.

### **2.1.4 Consequences of Athlete Not Meeting Obligations**

If an OPNST athlete does not meet the terms of their contract as outlined above in Section 2.1.2, the PNC/XCSO may at their discretion proceed with the following:

1. Written notice to the athlete to identify the infraction/action
2. Agreement/ signed contract with athletes as to their alternate commitments
3. Charging the athlete the full cost of PNC expenses incurred for their attendance on an OPNST trip
4. Removal from an OPNST trip
5. Notification of probation and/or removal from the OPNST
6. Not being selected for the OPNST in the subsequent year.

The Ontario Para-Nordic Trip Leader will be responsible for bringing potential failures to the attention of the PNC/XCSO. For any administrative obligations the XCSO Administrator will identify any issues to the PNC/XCSO.

The intent of this section is to ensure that all OPNST athletes honour their commitments and all are treated equitably. However, it is understood that extenuating circumstances may prevent an athlete from meeting some of their

commitments. Therefore, it is in the athlete's best interests to proactively discuss and identify any circumstances as soon as possible after the infraction occurs with the Ontario Para-Nordic Trip Leader and/or XCSO Administrator, as appropriate.

## **2.2 Ontario Para-Nordic Ski Team Selection**

### **Ontario Para-Nordic Ski Team (minimum of 4 up to max of 6 athletes)**

- Top athlete by PN CPL points, in each gender and discipline (standing and sitting) and;
- Compete in a minimum of two OC weekends as identified in Section 1.3. For standing skiers, races must include two of each technique and;
- Compete in at least 2 races at the 2017 Para Nordic National Championships

Discretionary Selection: Two additional athletes can be named to the OPNST by the discretion of the XCSO Para-Nordic Committee

### **2.2.1 Special Invitation to Ontario Para-Nordic Trips**

In general, team trips are available to identified team members only. Team members may decline a trip for school, health or other reasons. No replacement will be added, however the PNC reserves the right to invite additional athletes with exceptional performances or under unusual circumstances.

## **2.3 Effect of Race Cancellation on OPNST Selection**

In the event that any eligible selection races are cancelled, the following number of selection criteria races will be used:

- |                           |  |

| 1. One races cancelled:   | best 3 of 6 races, including 2 of each technique |
| 2. Two races cancelled:   | best 3 of 5 races, including 2 of each technique |
| 3. Three races cancelled: | best 2 of 4 races, including 2 of each technique |
| 4. Four races cancelled:  | best 2 of 3 races, including 1 of each technique |
| 5. Five races cancelled:  | best 1 of 2 races, including 1 of each           |

## technique

The selection of the Ontario Para-Nordic Ski Team and the Ontario Para-Nordic Development Ski Team will be recommended by the PNC to the XCSO Board for approval. In the event that ten or all races are cancelled, the PNC will be responsible for recommending athletes to the XCSO Board.

### **2.4 Effect of Race Technique Change on OPNST Selection**

In the event that a race technique must change (e.g., a change from a planned skate race to a classic race due to lack of snow), the PNC reserves the right to modify the “best of” calculation in-season in as fair a way as possible to reflect the actual race distribution over the racing season. Any modification to the “best of” calculation will be published to the Ontario ski community as soon as possible.

### **2.5 Force Majeure**

Ontario PN Ski Team. Injury, illness, family misfortune, exceptional circumstances and equipment breakage will be considered valid grounds for a force majeure appeal. Appeal documentation to be provided to Cross Country Ski Ontario must include but is not limited to:

- Physician letter if health related
- A letter/email outlining exceptional circumstances
- A letter/email from present personal/club coach indicating their intent to support their athlete as an OPNDST member.

Appeals will be evaluated by the PNC taking into consideration the reason for the appeal and results from other races. Force majeure documentation must be received no later than **5pm EST March 31<sup>st</sup>, 2018.**

### **2.6 Appeals for Ontario Para-Nordic Ski Team Selection**

Once the members of the Ontario Para-Nordic Ski Team been named and released on the XCSO website, any appeals of Para-Nordic Committee decisions must be made to the XCSO Board of Directors in writing by not later than **within 15 days of posting on [www.xcskiontario.ca](http://www.xcskiontario.ca).**
