- 4. Chair (Richard)
 - Consistent information coming from CCC with weekly email communication from CCC. HP activity will be reported by Jack
 - The decision to not have Easterns as a QC was made at the SFQ in September. Rationale was that with CWG and QC Winter Games, the province only wanted 4 QCups. As well, the distance to travel for Juveniles is more than they would prefer. Jean Baptiste (SFQ Technical Director) assures us that most Junior B/G and top end Juveniles will attend regardless. They are working on incentives to encourage participation.
 - One of the larger SOD clubs is indicating that they may withdraw their general membership
 from XCSO and CCC and only register members who are participating in CCC programming.
 This club has threatened this a number of times; however, I think they may very well go
 through with it this time. Their trail fees are so low, that in the case a family of five the CCC
 membership fee is higher than the trail pass. My only hope is that when they look at the fine
 print in whatever insurance policy they are looking as replacement, that they will see that
 there are some gaps.

- Commit to Kids policies
 - i. Documents circulated on Monday
 - ii. CCC has signed the pledge but waiting for more direction from the CAC
 - iii. Katja recommends that we continue on the path and not wait for CCC
 - iv. General Discussion: Responsible coaching Guidelines needs to be approved by the Board of Directors. Katja is suggesting that we purchase 20 licenses for club coaches (max of 3 per club) to complete the Commit to Kids online learning. Rule of 2 is problematic based on the number of female coaches and suggested that 'must' be replaced with 'should'. Issue with our sport being spread out over km. Concern about the implementation/practices. Suggestion that we develop a Best Practice and examine our risk situations. Open practices are not necessarily risky situations, however, a team trip would be a risky situation. Creation of guidelines rather than policies. Team practices and groups of youth could provide less risk. Clubs have been asking and a timeline needs to be developed. Criminal record check recommendations are also a part of this document, Standard of care is necessary for our sport. Description of risky situations would add to the document
