  - a) Review and motion for approval of COVID-19 Response and Return to Play Protocol
    - i. Return to Play Protocol Stage 1 & Stage 2 (Liz)

Document produced for Stage 1 and again Stage 2. Clubs have implemented the plans effectively. Other Divisions are using this as a source document. Some ambiguity in the requirement to follow social gathering size versus a business and being able to provide 2 metres of physical space. CSIO Chief Medical Officer will be following up with the Ministry of Health for clarification

- ii. XCSO Activities (SuperCamps, Coaching courses etc) during the summer/fall (Vic/Katja) A few weeks ago, we felt we needed to change direction and not bring athletes into a single location for a mass training camp. Victor and Katie will be travelling from TBay and Ottawa and will meet in Sudbury for a PN camp with Patti. Katie has been doing virtual training sessions with OST, NTDC, OJST, OPNST. Hosted a meet and greet with over 40 athletes in attendance.
- iii. Coaching Courses (Katja)
  - Nakkertok requested to host a LTT coaching course. There are a number of hurdles which need to be worked on with the CAC. Katja is working with Steven Novasad (Nordiq Canada) and Jen Tomlinson to develop a pilot program for a virtual landing session.
- iv. Planning the Competitive Season (Victor)

- 1) Ontario Cups: Plan A Business as Usual with District racing being incorporated into the overall calendar planning. This has evolved into an overall plan in the event of restrictions for competitions. Jack has asked about team selections and how that will be impacted with limited races and CPL and sanctioning. The District race series will be low key and focussed on the U16, U14 and U12 racers to encourage local racing. There is some support from Nordiq Canada to have TDs locally sourced which will reduce costs. Nordiq Canada will have an 8 week decision time frame for cancelling.
  - Plan B Reduced attendance, reduced venues, Plan C Travel Limitations, District events only., Plan D Virtual Events only
- 2) National-scope races: Thunder Bay and Ottawa Risks to local organizing committees and mitigation strategies
  - i. 8-week Cancellation Policy from NC
  - ii. Nakkertok will host Nationals, and there will be a NorAm Feb 19-20 in Thunder Bay. There are some concerns with respect to border closures and travel restrictions and the financial implications. Easterns will be held in Morin Heights and will not be an OCup. We will not schedule a race for that weekend allowing athletes to travel to Easterns.

  - i. Presentation from Denis regarding eligibility

    If we legitimately qualify for the CEWS, we should apply for the funds discussed.

    From the CEWS As a Canadian employer whose business has been affected by COVID19, you may be eligible for a subsidy of 75% of employee wages for up to 24 weeks,
    retroactive from March 15, 2020, to August 29, 2020. This wage subsidy will enable you
    to re-hire workers previously laid off as a result of COVID-19, help prevent further job
    losses, and better position you to resume normal operations following the crisis.

    Concerns with credibility in applying for this and taking advantage of the program.
    Concerns that our future ability to pay staff in the future may be negatively impacted.

    Our future funding from the government may also be negatively affected.
  - iii. Motion to direct the Executive Director to apply for the 75% Canadian Emergency Wage Subsidy.Moved by Jack Sasseville, Seconded by Dwayne Barber
    - Motion passed
- c) Settle a date for the AGM using Google Meet (?) Options: Minimalist or Working Session?
  - i. Minimalist: primarily reports in advance, not much discussion, election of board or a larger working session with breakout groups to discuss and develop strategic plan. Nordiq Canada's AGM is September 9th. Jack indicated that audio/video issues can create problems and suggested that a minimal AGM is recommended. Amy suggested that clubs are also planning and time is better spent planning the season. Wednesday, September 16th set for the AGM.
